ANNEX- 1 Price List

The operator is obliged to pay 10% of the amount specified in the F-P01.04.01 Organic Agriculture Control and Certification Price Offer Form within 10 days following the signing of the contract, and the remaining amount within 10 days following the presentation of the invoice. For contracts for which the amount is not paid (including analysis), no control is carried out in accordance with the TR Regulation and EU Regulation, no certificate is issued, and all of the operator's work and operations related to organic agriculture are suspended.

The inspection day period is determined as the minimum in the price offer and the inspection period realized cannot be below this value, however, if the inspection period is extended due to reasons not caused by Başak Ekolojik, such as the number of parcels, transportation time, not being ready for inspection, the additional time is invoiced to the operator after the inspection.

Travel, accommodation and meal expenses are calculated based on the invoices submitted to Başak Ekolojik accounting by the controller after the inspection and are invoiced to the operator by Başak Ekolojik. If requested by the operator, estimated travel, accommodation and meal expenses are specified in the F-P01.04.01 Organic Agriculture Control and Certification Price Offer Form. However, if an expense exceeds this estimated amount during the inspection, the exceeded amount is invoiced to the operator after the inspection.

The cargo or registered mail costs of all kinds of shipments made by the operator or Başak Ekolojik are covered by the operator.

¹ The office services period includes the receipt and evaluation of the application of the operator or group operator, preparation of the offer and receipt of the approved offer, mutual signing of the service contract, examination of the Organic System Plan, Electronic Information System entries, examination of the control reports by the certifier , and creation of the file.

² **Transportation;** It is the number of days spent to go to the address where the control was carried out and to return. 8 hours of transportation time is included in the calculation as 1 day.

³ **Transaction Certificate; For transaction certificates containing up to** 100 tons of product, the service fee stated above is requested per item. If the product quantity exceeds 100 tons ; for each 100 tons increase, half of the above-mentioned amount (50%) is added.

⁴ **COI/BB COI Issuance;** For sales to EU member countries and Great Britain, the service fee stated above is requested per COI/GB COI certificate containing up to 20 tons of product. If the amount of product contained in the COI/GB COI is over 20 tons; 5% is added to the above-mentioned figure for each 1-ton increase.

European Commission Directorate General for Agriculture and Rural Development (European Commission Directorate General For Agriculture And According to the notification made by Rural Development), additional control measures will be applied to the products listed in the list of countries, including Turkey, listed in the notification. For products subject to additional control measures, twice **the COI/BB COI Preparation** fee is requested.

⁵ NOP Import Certificate; For NOP Import certificates containing up to 20 tons of product, the service fee stated above is requested per item. If the product quantity in the application is over 20 tons; for each 1 ton increase, 5% is added to the above mentioned amount.

^{6.} **Re-issuance of the Operator Certificate and its Annexes;** The first preparation of the Operator Certificate and its Annexes within each contract period is free of charge. However, if the Operator Certificate is re-prepared upon the request of the Operator, the fee stated above will be charged.

^{7.} **Response to OFIS Notifications;** covers the control and office services performed in case of receiving an OFIS notification.

⁸ **Residue Investigation;** It is the amount to be invoiced per residue notification received from the control organization and/or authorized authorities (except for OFIS notifications).

⁹ Sampling ; It refers to the service fee determined for samples taken, except for samples taken during annual controls. In calculating the fee, the service time spent for transportation to the address where the sample will be taken, return and sample collection is calculated.

¹⁰ **Surveillance Control;** This is the control that takes place if there is a physical control requirement for the operator before the Product/Circulation/COI/Import certificate is issued.

¹¹ **Follow-up Control;** It is the control carried out in case of a suspected or detected non-conformity outside of the control and especially in researches.

¹² Additional Inspection with and/or without an announcement ; refers to additional announced and/or unannounced inspections carried out for residue notification, non-compliance that has not been closed, risky products, intermediate products or products that take a long time to harvest, etc., in addition to the annual additional announced and/or unannounced inspections included in the F-P01.04.01 Organic Agriculture Control and Certification Price Offer Form.

¹³ Appeal; If the objection is not found to be justified after evaluation, the amount determined per objection will be invoiced to the objector. If the objection is justified, no invoicing will be made.
